- Having seen Royal Kram No. ស្រ/រកម/0902/018 dated September 25, 2002 promulgating the law on Social Security Scheme for persons prescribed by the provisions of the Labor Law;
- Having seen Royal Decree No. ស្រ/រកត/1297/91 dated December 31, 1997 regarding Judicial Statute of Public Establishment of Administration;
- Having seen Sub Degree No. 52 អនក្រឹត្យ..បក dated April 01, 2005 regarding the organization and functioning of Ministry of Labor and Vocational Training;
- Having seen Sub Degree No. 04 អនក្រឹត្យ..បក dated January 20, 2000 regarding the organization and functioning of Ministry of Economy and Finance;
- Having seen Sub Decree No.16 អនក្រឹត្យ/បក dated March 2, 2007 regarding the establishment of National Social Security Fund;
- Referring to Reference by Samdech Prime Minister of Cambodia dated February 18, 2009 on the report of the National Economic and Financial Committee and Private Sector Development Leadership Committee.
- Having seen the request of NSSF Board

Hereby Decided

Article 1:

The contribution rate of occupational risk of 0.8 percents as stated in the Prakas No. 108 KB/ KRB dated June 16, 2008 on the Determination of the contribution rate and procedure of contribution payment for occupation risk shall be reduced to 0.5 percent for the Garment and Shoes enterprises/establishments. The reduction of this contribution rate shall be applied for two years i.e. 2009 and 2010. The other 0.3 percent shall be paid by the Royal Government of Cambodia.

Article 2:

Establishments and enterprises having already paid the 0.8 percent to NSSF for the months of the early 2009, NSSF shall make an offset for contribution payment for the following months based on the obvious exceeding amount of the months already paid.

Article 3:

Garment and Shoe Establishments and Enterprises are referred to all establishments under the scopes of garment and shoe sectors which include the embroidery, knitting, laundry, printing enterprises or establishments.

Article 4:

This Prakas shall take into effect from the date of its signature.
