Decision

Article 1._

Owner or Director of enterprise operate under Article 1 of Labour Law that require additional use of Labour force but unable to find or lack of number of Cambodian employee to fulfil any workplace or any type of work or any shift, the enterprise are able to request for additional foreign worker in special condition for over 10% of total Cambodian employees.

Article 2._

To use additional foreign worker in special condition owner or director of enterprise shall:

1. Letter request for approval of the use of foreign worker from Minster of Labour and Vocational Training attach with written employment contract of each foreign worker.

- 2. Fill in requesting form of employment book/card for foreigner on data controlling system of foreign worker through online system (FWCMS) via webpage www.fwcms.mlvt.gov.kh.
- 3. Pay the taxes on service fee of employment book/card for foreigner that stated in Joint Prakas of Ministry of Labour and Vocational Training and Ministry of Economy and Finance.
 - 4. Visa/Legal residency permit.

Article 3.

Owner or Director of enterprise or individual that violate any provisions in this Prakas shall be punish in accordance to Chapter 16 of Labour Law.

Article 4._

Any provision contrary to this Prakas shall be abrogated.

Article 5.

Chief of Cabinet, Director of General Department of Administration and Finance, Director of General Department of Labour and relevant Director of Department of Ministry of Labour and Vocational Training shall be in charge of implementing this Prakas as their respective role from the date of signature.
